I further understand that if this declaration or any other information provided in support of my application is found to have been false in any material respect, or if I breach any undertaking given in it in any material respect, then the Bar Standards Board shall refer such matters to the applicant's home regulator to be dealt with under their jurisdiction as appropriate.
